
Dear Members,

GREETING TO ALL THE AFFILIATED UNITS / MEMBERS OF TBCFI.

This is informing to all concerns that the Tennis Ball Cricket Federation of India. (TBCFI) hasn't sanction any National Events / Activities even though neither permitted nor allowed to organize any tournament on National championships on or before issuing of this letter as on 12th February, 2018 today up to the end of the March 2018 except as prior officially sanctioned events which was held in Bareilly (Uttar Pradesh) in the month of January, 2018.

As per Rules and Regulations of TBCFI, incase, if a person, unit or institution is going to organise such type of championships / activities / events without written prior permission from TBCFI authorities that such championships / activities / events which shall be treated / considered as illegal. The TBCFI may not be liable to responsible and also not to verify such certificate(s) issued as related to illegal Championships / Activities / Events for the participating players / officials. If any state unit found not to follow the Rules and Regulations of TBCFI and intentionally goes against the instructions of TBCFI as issued time to time will be treated debarred / considered separated from TBCFI. In such circumstances, the TBCFI can authorise or give the responsibility of enhancing the game of Tennis Ball Cricket as the case may be to the likeminded sports person / authority / organization in that respective State / Union Territories.


