Dear Sir / Madam,

It is extremely apologetic to inform you that TBCFI issued several instructions / notifications to all concerns affiliated units / organisations / associations which has not received so far concerning submission of details as under :

- Detail information of Unit / Organisation / Association;
- Contact details with mobile number of each member;
- Registration documents. (A Copy of the *Registration Certificate* issued by the Registrar of Societies concerning to your Unit / Organisation / Association).
- An Assurance affidavit / confirmation letter duly signed by the President, Secretary and Treasurer for future actively participation in the TBCFI activities. (As such activities ignoring from your end quite long period to till date of issued this letter).

As noticed by the TBCFI that some units were indulged in double role during the election of TBCFI and thereafter. The participations of such Units / Organisations / Associations are absolutely illegal and unauthentic in the election process and other activities as run by *Suspended Secretary, TBCFI, Mr. T.A. Lari*. Then why not terminate to such Units / Organisations / Associations.

In the above context, you are hereby requested to please furnish as such above mentioned details on or before 31st July, 2017. The TBCFI is highly displeased at the irresponsible and non co-operational attitudes with some Units / Organisations / Associations whom participation was nil during the **Election Process** of TBCFI in New Delhi on dated 04-08-2016. The non co-operational Units / Organisations / Associations as noticed are Uttar Pradesh; Chhattisgarh; AIIB; Rajasthan; West Bengal and Telangana.

It's further requested to all such Units / Organisations / Associations those who have participated in the Elections of TBCFI and other activities as such hold by suspended Secretary, TBCFI, Mr. T. A. Lari which is an illegal and unauthentic process to mislead in all manners. They are required to clarify their position as per allotted prescribed time limit as mentioned above. In case, if they are failure to do so in the prescribed time period means compelling to the TBCFI to take an appropriate action with no other options like Membership Termination except to consider afresh application for memberships with new contacts. Associations as noticed are Maharashtra, Bihar, Orisha Punjab, Vidarbha.
